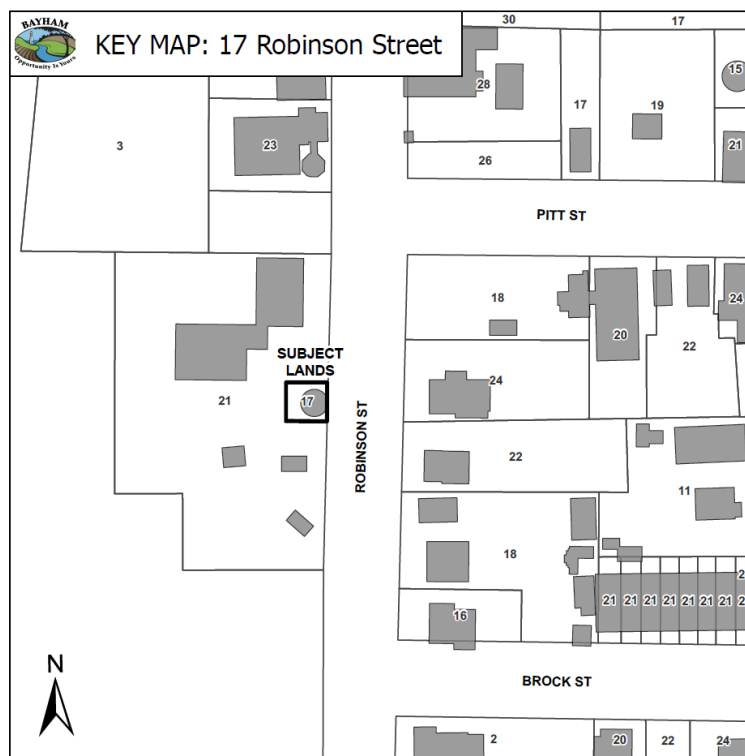
NOTICE
