DECISION

THAT the Committee of Adjustment Secretary/Treasurer's Report DS-19/26 regarding the Bilodeau minor variance be received;

AND THAT the Committee of Adjustment considered all written and oral submissions received on this application, the effect of which helped the Committee to make an informed decision;

AND WHEREAS the Committee agrees that the proposed variance as presented meets Section 45.1(1) of the Planning Act and is considered minor;

THEREFORE, Application COA-07/26, submitted by Rick and Dawn Bilodeau pursuant to Section 45 of the Planning Act, for a minor variance to permit a front yard depth of 11.924 metres for the construction of a garage extension, is granted relief from the Municipality of Bayham Zoning By-law No. Z456-2003 as follows:

- Section 5.8 to permit a Front Yard Depth of 11.924 metres where a minimum Front Yard Depth of 15.0 metres is required.

Decision: GRANTED

Reasons for the Decision:

- the variance is minor in nature in accordance with the requirements of the Planning Act
- the variance application meets the "four tests" of Section 45.(1) Planning Act
- the variance maintains the general intent and purpose of the Official Plan and Zoning By-law
