DECISION

THAT the Committee of Adjustment Secretary/Treasurer's Report DS-38/25 regarding the Wiebe minor variance be received;

AND THAT the Committee of Adjustment considered all written and oral submissions received on this application, the effect of which helped the Committee to make an informed decision;

AND WHEREAS the Committee agrees that the proposed variance as presented meets Section 45.1(1) of the Planning Act and is considered minor;

THEREFORE application COA-07/25 submitted by Kristi Wiebe pursuant to Section 45 of the Planning Act for a minor variance, is granted to allow relief from the Municipality of Bayham Zoning By-law No. Z456-2003 regulations to permit an existing accessory building to be converted into a single detached dwelling as follows:

- Section 10.3 to permit a <u>Minimum Lot Area</u> of 809 square metres, whereas 900 square metres is required, and;
- Section 10.10 to permit a <u>Rear Yard Depth</u> (for a dwelling) of 5.26 metres; whereas 7.0 metres is required.
